
# Environmental Monitoring Strategy Community Partners Engagement Survey Results

**Total Survey Responses = 34** 

The community partners engagement survey was sent to over 50 people. A list of survey participants was generated by the Integrated Management Team based on whether the person has had direct involvement with Kawartha Conservation programs or projects over the years. We also targeted community types that might benefit from our technical services. Our goal was to connect with people that were willing to provide constructive feedback on the survey.

## **Question # 1** – What community type do you represent?


Out of the 34 responses we received, we were fortunate to have one or more responses from all community types except one. The only community type that was not represented was First Nations. A survey was sent to this community type, but we have not received a response yet. Almost half of the participants came from either a Provincial or Municipal partner (49.9%), with academia and community partners coming in second with 14.7%. The OTHER community type consisted of a retired MNR and Environmental Consultant, volunteer, and lake resident.

## **Question # 2** - How would you describe your role at your organization?


There was a very high percentage of upper management job roles that participated in this survey, followed by techincal staff and community residents. The other category consisted of a volunteer, hired aid.

**Question # 3** – Has your organization been involved in or provided financial support towards any environmental projects over the years?


▶ 65% of survey responses have been involved or provided financial support towards our projects over the years, with only 35% answering No to this question.



Program Support


Question # 4 – Please indicate what type of contribution your organization has made?

Out of the 22 responses that answered "Yes" to the previous question, financial support was the main contribution at 38%. The second type of contribution came in at 19%, and this included all types, with in-kind contribution and volunteering tied at 14%. Some responses indicated that they have provided both Financial and In-kind support as well as Volunteer and In-kind.



Contribution Type


This graph represents the breakdown of support by organization type. As you can see majority of our financial support comes from all levels of government, community partners and NGO organizations. Academia and agricultural sector tend to contribute more through In-kind and volunteer opportunities.



Organization vs Support Type


**Question # 5** – Are you familiar with any of the current environmental programming we do?

For this question we expected all survey participants to be familiar with our programming, but it turns out 15% of the survey participants were not familiar. Those not familiar included participants from municipal government and a resident.



Program Awareness


Out of the 29 responses who said "Yes" to being familiar with our current environmental programming, water quality and aquatic sampling were two of the most recognized with temperature and groundwater monitoring being less familiar. Other areas in which we were known for by community partners included wetland monitoring, Ecological Land Classification (ELC), Climate and Hydrometric monitoring, Beach Monitoring, Bacteriological Sampling and Flood Forecasting and Warning.

**Question # 6** – Does Kawartha Conservation currently provide environmental data to your organization?


Almost half of the responses indicated that Kawartha Conservation does provide environmental information to their organizations, while just over 25% indicated that Kawartha does not provide data or that they did not know. Organizations that fell within that percent bracket included government (provincial and municipal), academia, agriculture, community partner and NGO.



Provider of Data


## **Question # 7** – What is the current format of data delivery?

For those 47% of the survey responses that answered "Yes" to Kawartha Conservation providing data to their organization, the most common methods of data delivery included reports, email correspondence and other. Some of the items listed in the "Other" category included information being delivered at meetings, downloading data directly from some of our monitoring stations and through fax distribution.




**Question # 9** - Does your organization have any environmental data gaps that the Integrated Watershed Management Team could assist with?

> Just over half of the survey responses indicated that their organization had environmental data gaps that the Integrated Watershed Management team could assist with.




Environmental Data Gaps

> Of those 52% that answered "Yes", the list below represents the environmental data gaps that survey participants suggested Kawartha Conservation could assist with.




**Question # 10** – Would you be interested in participating in Kawartha Conservation Environmental Monitoring Strategy Guidance Group?
